This is a basic introduction to living trusts. General concepts are explained: differences between a trust and will, funding a trust, the various types, problems, and other related subjects. The most valuable section is Appendix A. The author provides valuable sample forms: letters to creditor, Social Security Administration, life insurance, Veteran's Administration, and employer; funeral and burial arrangements; and obituary format.

The majority of the population does not have a will or Living Trust according to the author, probably because they think their assets are not sizable enough, and they see no `urgency'. But the fact is that for any asset big or small, drawing a Living Trust is cannot be put off. The author-attorney has a written a book in plain language the difference between a will and Living Trust. Almost any basic information one needs on the subject is in this book. There are many books on the subject, but the uniqueness of this book is that it tells the facts of the aftermath-what the family must do when the trustee dies. This is invaluable information at the readers' fingertips. This is a book every family/trustee/heirs must have. The author has done a great service.

This book is excellent. It shows you why a trust is far superior to a will, and less hassle when someone dies.
