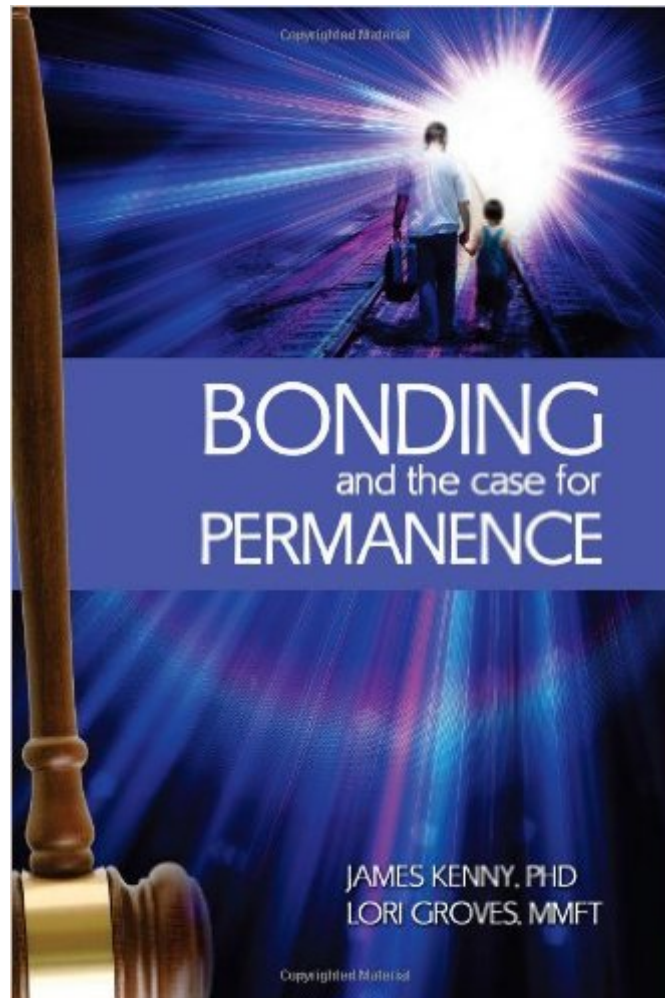

The connection between parents and children is undeniable, but whose interests are more important? When children enter foster care this question is often difficult to answer, but authors James Kenny, Ph.D., and Lori Groves, MMFT, have created a guidebook to answer that question, as well as many others in their new book, "Bonding and the Case for Permanence." With a whole chapter dedicated to defining bonding, the duo map out a guide for professionals to follow as they create a case plan for children. From caseworkers and judges to foster parents and Court Appointed Special Advocates, a path that emphasizes the child's needs for permanence is clear. With statistical evidence supporting the importance of permanence for children, the authors also promote the use of the Adoption and Safe Families Act. Throughout the book, the authors identify problems that exist within the child welfare system while providing a clear step-by-step process to correct the

errors in the system to guide the most important element: children. This is an interesting book because it is extremely technical in nature, which might turn many readers away. However, the format in which it has been written makes it easy to understand and use. In my opinion, this book should be on the shelves of any caseworkers, attorneys or judges who make decisions on behalf of children. The clear message in the book would provide these professionals with a manual to follow while making difficult decisions about children, their families and their futures. With several appendices at the end of the book, it provides easy-to-use worksheets that can help parents as they attempt to adopt children from the foster care system.
