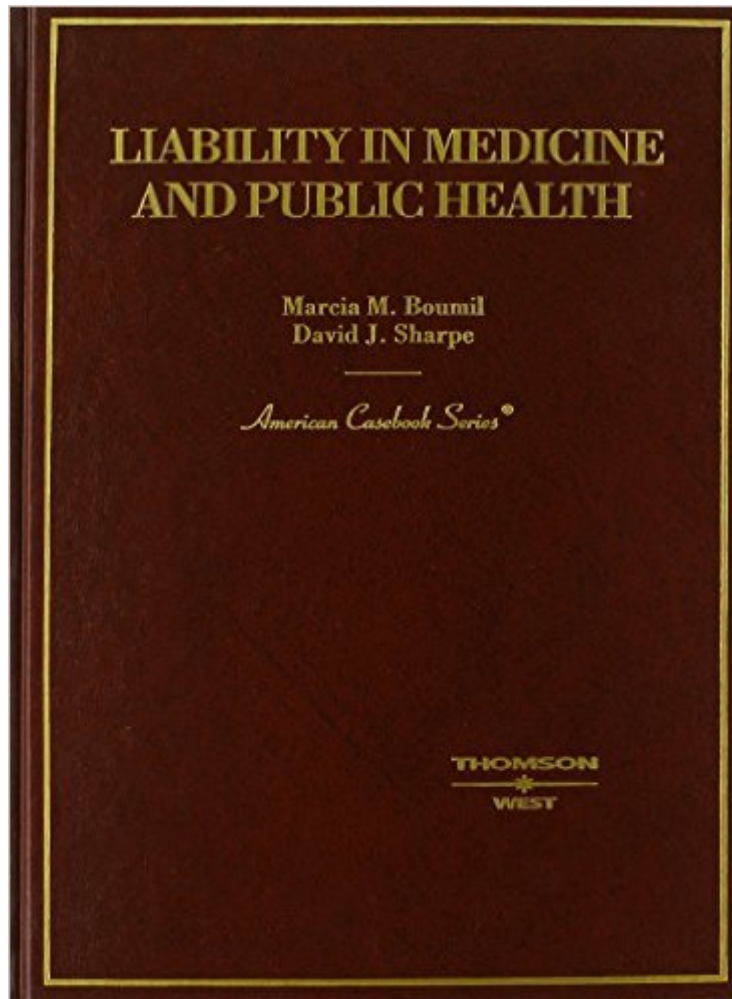

## Synopsis
